I, \_\_\_\_\_ (“Guardian”) hereby certify that I am the legal guardian of the above-named Student. I acknowledge reading and understanding the statements that the Student made above. I acknowledge that the educational and social environment of the College is designed for adult students, aged 18 or above. The College may, in its discretion, waive the 18 and over requirement for Students who will turn 18 within one month of the start of the semester, subject to among other things the Student and Guardian completing this Consent and Waiver form. I acknowledge that the College has no obligation to grant the waiver, and that the College may at its discretion decide to withdraw this waiver at any time. I acknowledge that this waiver is not only for a College program, class or event, but also includes computer and science labs, physical fitness facilities, chapels, storage rooms, equipment rooms, athletic facilities, outdoor activities and dormitory living.

I understand that College is primarily designed for adults and there is a possibility that the content covered in classes may include controversial topics and it is important to evaluate the maturity of minor students and their ability to learn the content and perform at an equivalent academic level to the adults in the classroom. We recommend that you consider and pray about the decision carefully.

I understand that the social and living environment of the College is designed for adults. Although we strive to maintain a Christ honoring environment, and to enforce campus standards and a Code of Conduct on campus, it is important to recognize that students who are not yet 18 will be living in dormitories with students who are 18 and older. We again recommend that you consider and pray about the decision carefully.

Upon admission to the College, the Student is officially enrolled in an institution of higher education, and as a result, the Student is protected by the Family Educational Rights and Privacy Act [FERPA] of 1974, and Guardian will be limited in the extent to which he or she can interact with Student’s professors and have access to the Student’s records.

I agree that I shall be available in case of an emergency involving the Student. I acknowledge that the College will use reasonable efforts in responding to issues regarding Student, but I acknowledge that the College shall not be expected to provide any heightened oversight measures for Student's benefit while on the College's property, in a program, class or event.

I, on behalf of Student, agree to abide by the [Student Policies Handbook, Code of Conduct], and all other policies and procedures of the College applicable to adult students. I, on behalf of the Student, hereby

assume all risks of injury, illness, death, or other loss arising from Student's participation in programs, classes, events or presence on the College's property. I acknowledge that Student's use of facilities may expose Student to hazards or risks that may result in Student's illness, personal injury or death, and I understand and appreciate the nature of such hazards and risks. I agree on behalf of myself, the Student, and our respective heirs and representatives to release the College and its directors, officers, employees and representatives from all claims, losses and damage to Student's property and for any and all illness or injury to Student, including death, that may result from or occur during participation or use of the facilities of the College.

I acknowledge that this Consent shall be under the laws of California. If any term or provision of this Consent shall be held illegal, unenforceable or in conflict with any law governing this Consent and Waiver, then I shall be bound by the balance of the remaining agreement to the fullest extent permitted by law.
